# Daniela Cristina Ghițulică



Cristina Ghiţulică is Professor of Chemical Engineering at the Politechnica University of Bucharest, Romania, with an academic career of more than 25 years long. Prof. Ghiţulică is also General Manager of the Romanian Agency for Quality Assurance in Higher Education (ARACIS) since 2022. She was the Vice-President of the ARACIS Council between 2015 and 2021. She has an extensive experience in the field of quality assurance as she has been working at ARACIS in different capacities, namely an external evaluator and member of the

Distance Education Commission since 2009.

At the international level, Prof. Ghiţulică is a member of the Bologna Follow-up Group (BFUG) on behalf of the Romanian Ministry of National Education since 2012. She was a cochair of the BFUG during the Romanian Presidency of the Council of the European Union ( $1^{st}$  of January –  $30^{th}$  of June 2019). She is currently co-chair of the BFUG Thematic Peer Group C (TPG-C) on Quality Assurance and of the Task Force on Enhancing Knowledge Sharing in the EHEA community.

In the past, Prof. Ghiţulică was the President of the Central and Eastern European Network of Quality Assurance Agencies in Higher Education (CEENQA) while since 2014 she was a member of the board of the network. Mrs. Ghiţulică was elected in 2018 as a member of the European Association for Quality Assurance in Higher Education (ENQA) Board and since 2019 she is Vice-President of the same organization.

# **Michael Mawa**



Professor Michael Mawa is the Head of the Quality Assurance and Qualifications Framework Unit at the Inter-University Council for East-Africa (IUCEA). Prof. Mawa has a substantial experience in quality assurance in higher education as he previously served as the Director of Quality Assurance at Nkumba University, Uganda. He is the founding President of the Ugandan Universities Quality Assurance Forum (UUQAF) and founding President of the East African Higher Education Quality Assurance Network (EAQAN).

Prof. Mawa has served as a Quality Assurance Expert in programme assessment, institutional assessment and quality assurance training for the National Council for Higher Education in Uganda, the Commission for University Education in Kenya, the Tanzania Commission for Universities and the Inter-University Council for East Africa. He has also been engaged in

quality assurance trainings organized under the Higher Education (DIES) of the German Academic Exchange Service (DAAD) TrainIQA programme for West Africa and SADC region. He has been trainer as well for the IIEP-UNESCO Internal Quality Assurance Training Programme for universities in Africa and Middle East.

#### **Andreas Snildal**

He holds a PhD from the University of Oslo, Sweden, where he also has worked as a lecturer and researcher in modern history.
