This will be the second on-line *Conversation on Academic Recognition* organised by the *Africa sub-group* of the *Coordination Group on Global Policy Dialogue* of the *Bologna Follow-Up Group (European Higher Education Area).*

The *Conversation* will allow experts from the European Higher Education Area, Africa and other South Mediterranean countries to informally exchange views, experiences and good practice on key issues such as the recognition of prior learning and of learning acquired in non-formal (including digital) settings, the case of migrants, refugees and displaced persons, as well as innovative approaches to recognition, such as micro-credentials.









The Conversation will include a plenary session with *simultaneous interpretation from/into English, French and Portuguese,* and three thematic language-specific breakout sessions – respectively in English, French and Portuguese – with no interpretation. You will find attached a draft programme and some background information.

Attendees will be muted, but an **online chat facility** will enable them to ask questions and to contribute in writing, in English and French. The most relevant contributions will be put to the panel on stage.
